Registration Fee (non-refundable):

\$250 per child if paid by March 1, 2025

\$300 per child if paid after March 1, 2025 (returning families)

Payment Options:

1. Payment in full via FACTS tuition plan (\$100 deduction if paid in full by August 1, 2025).
2. Eleven monthly payments via FACTS tuition plan (July thru May on the 5<sup>th</sup> or 20<sup>th</sup> of the month).

#### Tuition Collection Policy – 2025 -2026 School Year

ALL SCHOOL FAMILIES ARE STAKEHOLDERS IN THE MISSION OF PROVIDING QUALITY EDUCATION FOR YOUR CHILD(REN). We ask for your understanding and support of the partnership as we implement policies that will ensure a viable and healthy future at St. Ambrose School.

We will once again combine tuition and book fees into one total fee per family, which can be paid in one single payment or in 11 monthly installments.

1. **Single payment.** Families have the option of paying the full amount of tuition by August 1, 2025 via FACTS payment plan. Tuition is discounted \$100 if this payment method is selected.
2. **Monthly payments.** If you prefer to make monthly payments, the tuition is divided into 11 monthly payments from July to May. Monthly payments are to be made via FACTS payment plan.

#### Monthly Payment Method

1. Monthly tuition payments can be set up in FACTS to be paid on either the 5<sup>th</sup> or the 20<sup>th</sup> of the month, with the exception of 8<sup>th</sup> grade **only** student for the month of May 2026, payment needs to be set for the 5<sup>th</sup> of the month.
2. If a payment is returned for insufficient funds (NSF) or a closed account, you will have ten days to remake the payment. FACTS will assess a \$30 fee.
3. A delinquent account of 30 days or more will result in the student(s) being held out of school on the 10<sup>th</sup> of the following month, until the payment is made.
4. Repeated collection problems may result in the dismissal of the student(s) from school.
5. Report cards will not be released if there is a past due balance.

7. If a family experiences a financial hardship, they are responsible for scheduling a meeting with Fr. Jack Siefert to discuss their situation. If a financial arrangement is agreed upon, it must be put in writing and signed by a parent and Fr. Jack Siefert.
